James Turner, a principal since 1973 in the Washington, DC, law firm of Swankin & Turner, represents businesses, individuals and consumer groups on food, drug, health, environmental and product safety regulatory matters. He served as special counsel to the Senate Select Committee on

Food, Nutrition, and Health and the Senate Government Operations Subcommittee on Government Research. He was lead attorney on a successful petition to the FDA to permit legal U.S. importation and distribution of Acupuncture needles. He lobbied successfully for the Organic Food Production Act and The Nutrition Education and Labeling Act, both of 1990, and the Dietary Supplement Health and Education Act of 1994 (DSHEA).

He is a 1969 graduate of The Ohio State University Moritz College of Law, served as a gunnery and nuclear weapons handling officer in the U.S. Navy, and wrote “The Chemical Feast: The Nader Report on Food Safety at the FDA.”

Diane Miller, JD



Diane Miller's Lobbying Workshop 101 will provide Diane's top recommendations for individuals who wish to get involved in advocating for things they are concerned about, and for those who want to lobby a bill forward at a legislature. Her goal is to help citizens understand and implement successful lobbying strategies.

Diane Miller JD is an attorney and Director of Law and Public Policy for National Health Freedom Coalition (NHFC) and its sister lobbying organization, National Health Freedom Action (NHFA).

As the Co-Moderator of the US Health Freedom Congress and as an educator, lobbyist, and advocate for collaboration among health freedom leaders, Miller works to teach and implement the principles of health freedom in all areas of health including protecting the right of all people to access all health care information, services, treatments and products that the people deem beneficial for their own health and survival.

board of Voice for HOPE [HealersOfPlanetEarth] and a voting member of the Congress.

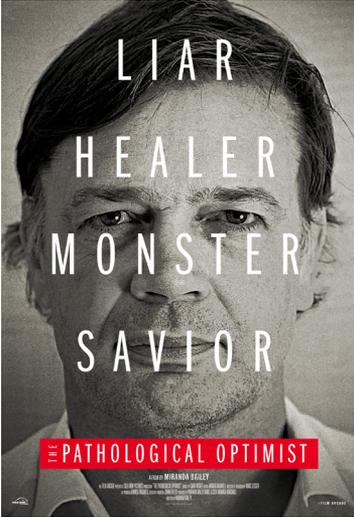

Dr. Mark Geier and David Geier

Awarded “For their courageous, successful legal challenges against the Maryland Board of Physicians. Dr. Mark Geier won his case, brought against the Board, for breach of medical privacy and obtained \$2.5 million in damages—half of which is to be paid individually by the Board’s members and attorney. David Geier won his case, brought against him by the Board, for charges of practicing medicine without a license.”

Biographies

Mark R. Geier, MD, is a Fellow of the American College of Epidemiology. He was a research scientist at the National Institutes of Health, and assistant professor at Johns Hopkins School of Medicine. He practiced clinical medicine for over 30 years and treated more than 1,000 patients diagnosed with autism and other neurodevelopmental disorders. He coauthored more than 150 studies in academic journals and is the co-founder and co-director of the nonprofit Institute of Chronic Illnesses, Inc, and the nonprofit CoMeD, Inc.

David A. Geier has coauthored more than 100 studies in academic journals and medical textbook chapters and presented at numerous academic conferences. He is the co-founder and co-director of the non-profit Institute of Chronic Illnesses, Inc, and the non-profit CoMeD, Inc. Mr. Geier participated on behalf of CoMeD, Inc, at multiple meetings of the UN Environmental Programme to prepare a global legally binding treaty on mercury to help reduce global human mercury exposure and harm.

Awarded “For their coordination of the Region 5 states in standing up to the federal Office of Child Care, which was attempting to condition receipt of federal funds under the Child Care and Development Block Grant Act of 2014 upon Ohio needing to do corrective action involving eliminating vaccine exemptions based on “conscience” from their existing law. Their successful resistance resulted in a determination by the Office of Child Care that states have flexibility in deciding how to address exemptions and that NO STATE would be under corrective action for exemption language.”

Ohio Advocates for Medical Freedom is a non-partisan group advocating for your right to accept or decline any medical treatment or procedure. OAMF is comprised of ordinary people who have come together with one goal in mind: the preservation of medical freedom. Founded in 2015, OAMF is a diverse group of people with professions including doctors, nurses, engineers, lawyers, and other healthcare providers. We all share the same concern and have learned that the only way to stop medical mandates and the infringement on medical rights is to organize and push back against bad legislation and policies. We base our strategies in fact and truth and present that information to the public and legislators.

Awarded “For passing into law Maine LD 725, titled An Act to Recognize Local Control Regarding Food Systems. With the passage of LD 725, which states that “a municipal government may regulate by ordinance local food systems, and the state shall recognize such ordinances”, Maine became the second state in the nation to allow consumers to buy directly from farmers and food producers regardless of the state and federal licensing and inspections that would otherwise apply.”

A retired nurse and midwife, **Betsy Garrold** devotes herself to writing and activism on local farming and food rights. She currently serves on several boards: Food for Maine's Future, the Belfast Co-op and as Vice President of the National Family Farm Coalition. She is a worker-owner at the Fedco Seed Cooperative and a lobbyist for the Farm-to-Consumer Legal Defense Fund. She blogs at thepopulistfarmer.wordpress.com and homesteads at her farm, The Shire, in midcoast Maine.

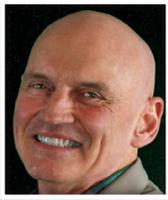

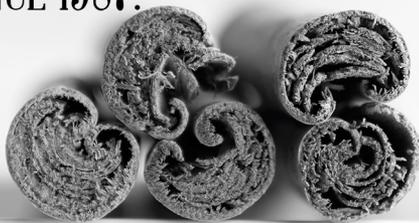

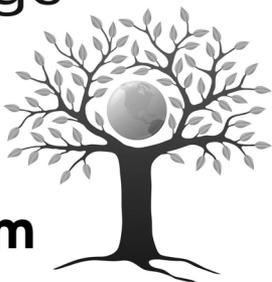
